Proper rust inhibiting requires the skill of an experienced technician who has an intimate knowledge of the body construction of your vehicle. His procedure is outlined below.

Compound is applied to all underbody panels other than powertrain components, exhaust system and steering linkages. All seams and joints are sealed with the compound.

All accessories and trim are removed from the trunk and the compound is applied to all seams, joints and side panels other than soft trim areas.

Access holes are drilled where necessary in all panels not otherwise open or accessible and compound is thoroughly applied by spray nozzle to these inner surfaces.

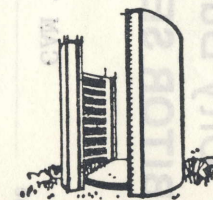
All areas under the hood are coated other than the engine and electrical components.

All exterior surfaces are cleaned to remove drips and runs from excessive spray.

This warranty is provided to the undersigned original owner only, for a period of five years or 50,000 miles, whichever first occurs, from the date of service, and is non-transferrable.

Coverage under this warranty extends only to rusting through of treated metal surfaces, from rust originating on the treated side of such surfaces. Therefore, this warranty does not apply to rusting originating on exterior surfaces, whether caused by defective paint protection, stone chipping, collision, abrasion or any form of vehicle abuse, nor does it apply to rusting of any chrome or other metal plated body trim.

This warranty shall become totally void if the rust inhibiting coating is altered, tampered with or removed, or if the treated vehicle parts are re-treated by other than City Buick Pontiac Cadillac Ltd. This warranty is void as to collision damaged vehicle parts unless within 30 days after repair thereof the vehicle is returned to us for inspection and necessary re-treatment of such parts, at the owner's expense. In addition the vehicle must be returned to us annually for free inspection and warranty validation (inspection record on reverse hereof). FAILURE BY THE OWNER TO RETURN THE VEHICLE FOR REQUIRED INSPECTIONS WILL VOID THIS WARRANTY.

IF OUR INSPECTION AFORESAID DISCLOSES RUST DAMAGE TO WHICH THIS WARRANTY EXTENDS, CITY BUICK PONTIAC CADILLAC LTD. WILL, AT ITS OPTION, REPAIR OR REPLACE THE AFFECTED VEHICLE PARTS, AT NO COST TO THE UNDERSIGNED ORIGINAL OWNER.

There are no representations, warranties, conditions, guarantees, or collateral agreements, express or implied, statutory or otherwise, made or given in connection with the rust inhibitor servicing above identified, except as expressly stated herein.
